
**ARTICLE VII. RESTRICTIONS ON TRANSFER OF MEMBERSHIP INTEREST.**

**ARTICLE VIII. INDEMNIFICATION.**

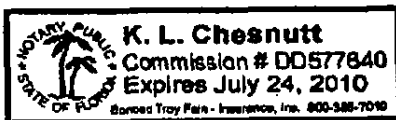


