1. Name. The name of the limited liability company is PHONE XP 7, LLC (the "Company").

2. Articles of Organization. The date of filing of the Articles of Organization of the Company was September 20, 2006 (Document Number L06000092404).

3. Amendment. The Articles of Organization of the Company are hereby amended as follows:

Article 1 is deleted and a new Article 1 is inserted in lieu thereof, to read as follows:

ARTICLE 1 - NAME

The Name of the Company is FGM SERVICES, LLC. (hereinafter, the "Company").

4. Adoption of Amendment. Pursuant to Section 608.411 of the Florida Limited Liability Company Act, PHONE XP 7, LLC adopts these Articles of Amendment.
