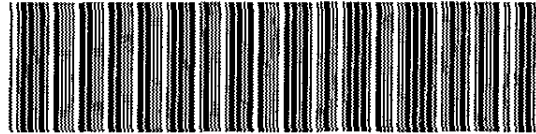

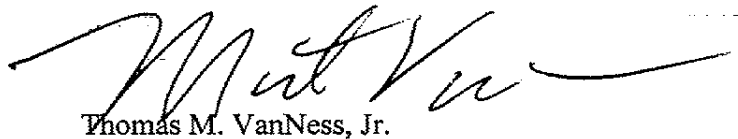

**ARTICLES OF ORGANIZATION OF  
CENTRAL FLORIDA EQUIPMENT, L.L.C.**

**ARTICLE I. NAME**

The name of the Limited Liability Company ("Company") **CENTRAL FLORIDA EQUIPMENT, L.L.C.**

**ARTICLE II. PURPOSE**
