

# ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF BAYSHORE SUNVEST DEVELOPMENT, LLC, A FLORIDA LIMITED LIABILITY COMPANY

Pursuant to the provisions of Chapter 621, Florida Statutes, the Articles of Organization of BAYSHORE SUNVEST DEVELOPMENT, LLC, a Florida limited liability company (the "Company") which were filed with the Secretary of State for the State of Florida on September 21, 2006 are hereby amended as follows:

- 1. The purpose for which the Company has been organized is hereby amended to be:
