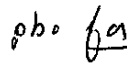

- SECOND:** The following Amendment to the Articles of Organization was adopted by the limited liability company:

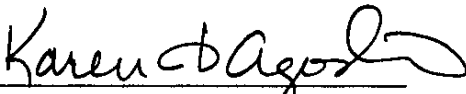
ARTICLE FIVE MANAGEMENT is hereby deleted in its entirety and replaced with the following:
