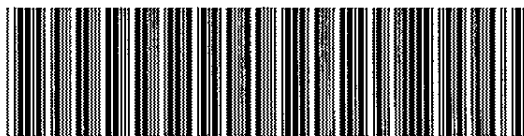

**ARTICLE I - Name:**

The name of the Limited Liability Company is: **M. CAMPBELL CONTRACTING, LLC** (hereinafter the "Company").
