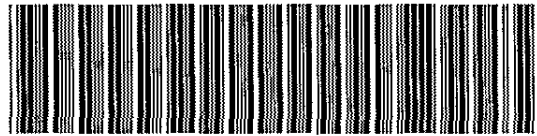

This Limited Liability Company may engage in any activity or business permitted under the laws of the United States of America and of this State.


**ARTICLE VI.
