ARTICLES OF ORGANIZATION OF DCG SERVICES, LLC

The undersigned hereby certifies that she is the authorized representative of the initial members who have associated themselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. She further declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE I NAME AND MAILING ADDRESS AND PRINCIPAL PLACE OF BUSINESS
