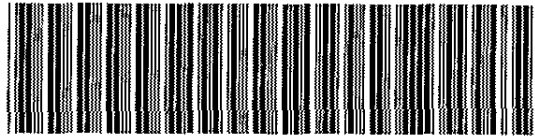

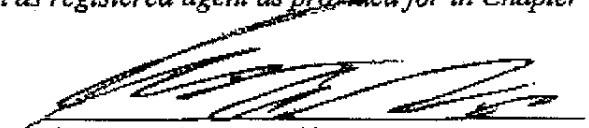

RIGHT OF THE MEMBERS TO ADMIT ADDITIONAL MEMBERS
