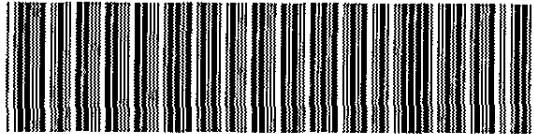


ARTICLE VII
