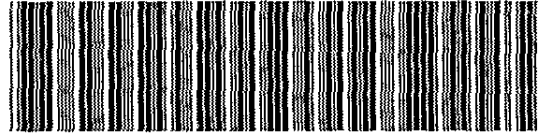



ARTICLES OF ORGANIZATION

OF

The undersigned hereby files the following Articles of Organization, for the purpose of forming a limited liability company under the laws of the State of Florida.

A member's interest in the limited liability company may not be sold or otherwise transferred except with the written consent of the managing member.




