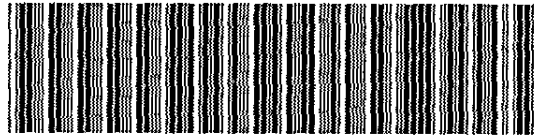

ARTICLES OF ORGANIZATION OF EEG PROPERTIES OF NAPLES, LLC

ARTICLE VI - NEW MEMBERS




