ARTICLE I - NAME

ARTICLE V - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida is Anthony S. Jagopat, 1322 N Pine Hills Road, Orlando, FL 32808.

ARTICLE VI - ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on the terms and conditions as shall be determined by all the members. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 
