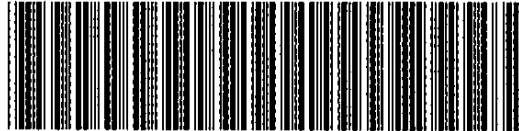

NAME**

The name of this limited liability company is NP & JP Holdings, LLC, referred to in these Articles of Organization as the "Company."


**ARTICLE VII


