

ARTICLES OF ORGANIZATION OF NP & JP HOLDINGS, LLC, A FLORIDA LIMITED LIABILITY COMPANY



ARTICLE NAME

The name of this limited liability company is NP & JP Holdings, LLC, referred to in these Articles of Organization as the "Company."

ARTICLE II REGISTERED OFFICE AND AGENT
