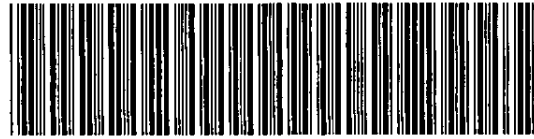

Juan C. Ramos, of 7344 SW 48th Street, Suite 202, Miami, Florida 33155, shall continue only as a Member of the Company.

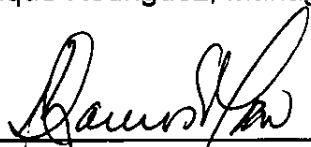
