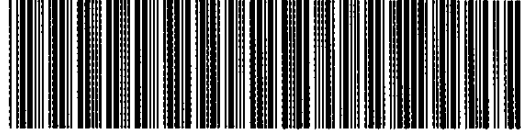

The purpose for which this Limited Liability Company is formed is to engage in business activities.

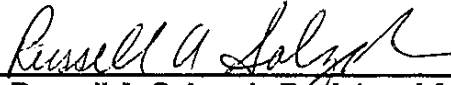
