FIRST ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF WORLD FIGHTING CHAMPIONSHIPS, LLC

Pursuant to the Florida Limited Liability Company Act, WORLD FIGHTING CHAMPIONSHIPS, LLC, a Florida limited liability company ("the Company"), hereby adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is: WORLD FIGHTING CHAMPIONSHIPS, LLC. The Articles of Organization of the Company were filed on September 27, 2006.

SECOND: Article 2 of the Articles of Organization of the Company is hereby amended and restated in its entirety as follows:

SIXTH: Article 9 of the Articles of Organization of the Company is hereby amended and restated in its entirety as follows:

The Company shall be managed by one or more managers in accordance with the Operating Agreement adopted by all the members and is, therefore a manager-managed company.
