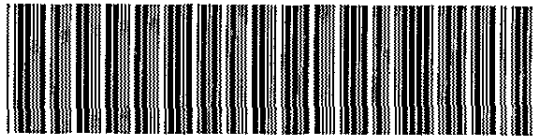


ARTICLE V
