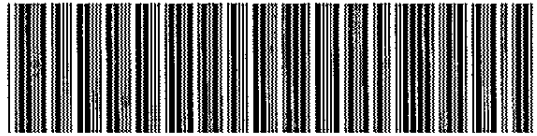

Principal Office


