**ARTICLES OF ORGANIZATION**  
**OF**  
**TRIAD CONSULTING GROUP, LLC**

In compliance with the requirements of F.S. Chapter 608, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Organization for the purpose of organizing a limited liability company.

**ARTICLE 1**  
**Name**

The name of the Limited Liability Company ("Company") is Triad Consulting Group, LLC.

**ARTICLE 2**  
**Duration**

The existence of the Company shall begin immediately effective upon the acceptance of these Articles of Organization by the Florida Secretary of State and shall be perpetual.

**ARTICLE 3**  
**Mailing Address**

The mailing address is 4607 NW 41<sup>st</sup> Street, Gainesville, Florida 32606. The street address is the same.

**ARTICLE 4**  
**Registered Agent and Office**

The initial street address of the Company's registered office is 4607 NW 41<sup>st</sup> Street, Gainesville, Florida 32606. The initial registered agent for the Company at that address is Sean M. Lewis.

**ARTICLE 5**  
**Admission of Additional Members;**  
**Terms and Conditions of such Admissions**
