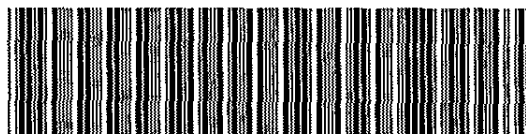

FIRST: The name of the Limited Liability Company is:

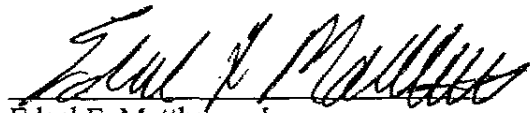
EXCL FITNESS, LLC

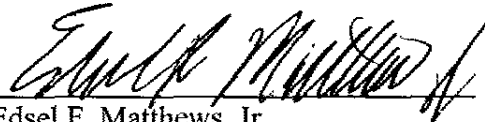
