

**ARTICLES OF ORGANIZATION

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of this Limited Liability Company is RED HOOK HOLDINGS, LLC.

ARTICLE II - MAILING ADDRESS

The mailing address and street address of the principal office of RED HOOK HOLDINGS, LLC, is 1044 Big Oaks Boulevard, Oviedo, Florida 32765.

ARTICLE III - DURATION

The period of duration for RED HOOK HOLDINGS, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

ARTICLE IV - REGISTERED AGENT & OFFICE

The name of the initial registered agent is Frank P. Leogrande. The street address of the initial registered agent is 1044 Big Oaks Boulevard, Oviedo, Florida 32765.

ARTICLE V - ADDITIONAL MEMBERS

Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.

ARTICLE VI - TERMINATION OF MEMBERSHIP

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in RED HOOK HOLDINGS, LLC, the remaining members may, by unanimous agreement, continue the business of RED HOOK HOLDINGS, LLC.

ARTICLE VII - MANAGEMENT

RED HOOK HOLDINGS, LLC is to be managed by managers and the name and address of the individuals who will serve as the managers are:




ARTICLE VIII - REGULATIONS
