**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF

The undersigned subscriber to these Amended and Restated Articles of Organization, being a natural person competent to contract as such under the laws of the State of Florida, and being the Manager specifically elected and directed by the Written Consent of Members in Lieu of Meeting dated even date herewith, hereby amends and restates the Articles of Organization filed with the Florida Secretary of State on September 26, 2006 and assigned document number H06000239500 3, in their entirety, pursuant to Section 608.411 of the Florida Statutes as follows:

ARTICLE I

Name. The name of the limited liability company is "LAKE NONA HOLDINGS, LLC" (the Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company is 1750 Via Tuscany, Winter Park, Florida 32789.

ARTICLE III

Duration. The Company commenced its existence on the date that the original Articles of Organization were filed with the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the Company's operating agreement.


