ARTICLES OF ORGANIZATION OF LOZANO INTERNAL MEDICINE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Fla. Stat. Ch. 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I

The name of the limited liability company shall be LOZANO INTERNAL MEDICINE, LLC ("Company").

ARTICLE II

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization.
