ARTICLES OF ORGANIZATION

OF

KEMY GROUP, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **KEMY GROUP**, **LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida state be 204 Northwest 9th Court, Miami Gardens, Florida 33169 and the mailing address shall the same.

ARTICLE 3 - EFFECTIVE DATE

<u>ARTICLE 7 - ADMISSION OF NEW MEMBERS</u>

No additional member(s) shall be admitted to the Company except with the unanimous written consent of all the member(s) of the Company and upon such terms and conditions as shall be determined by all the member(s). 

ARTICLE 10 - INDEMNIFICATION
