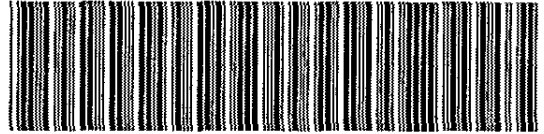

The name of the limited liability company is FNB VENTURES, LLC.


ARTICLE II - Principal Office
