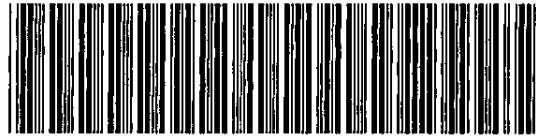



Buyer beware, as a formal complaint will be forthcoming to the Federal Trade Commission regarding the illegal business activities, presentations, and false pretenses of this UK Company. Briefly, upon repeated request to principal (vice president) David Stoneman for a UFOC as required by US law my request was not fulfilled. Company predicates a "turnkey" business and presents "franchise" opportunities to buyers. Both statements are not true as defined by US law. Formal letter submitted to company through principal David Stoneman on March 29, 2007 requesting a full, unconditional refund of monies paid to Infinet due to fraud and misrepresentation. Any and all assistance in obtaining my refund, and prosecuting this company from further damage to US consumers is greatly appreciated.
