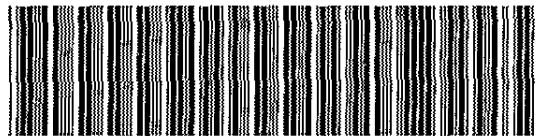

The undersigned, pursuant to the provisions of Chapter 608 and Chapter 621 of the Florida Statutes, for the purpose of forming a professional limited liability company, under the laws of the State of Florida, does hereby set forth the following:

ARTICLE I
NAME

The name of the professional limited liability company is:

ARTICLE II
PERIOD OF DURATION

The period of duration of the professional limited liability company shall be from the date of filing these Articles of Organization until the dissolution of the professional limited liability company pursuant to provisions of the Florida Limited Liability Act and the Florida Professional Service and Limited Liability Act.

ARTICLE III
PURPOSE

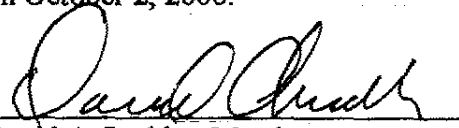
ARTICLE XI
