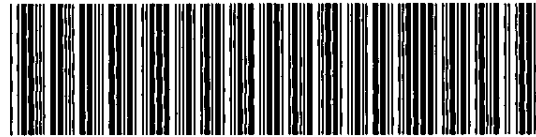

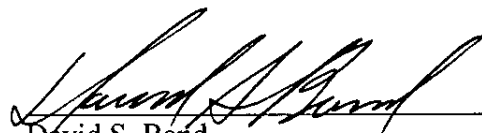
The Company has terminated its business.
