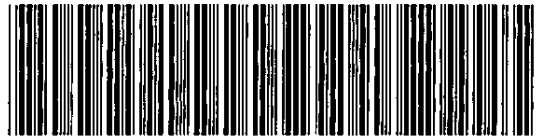

The name of the Limited Liability Company is GLOBAL GAS PRODUCTS LLC.

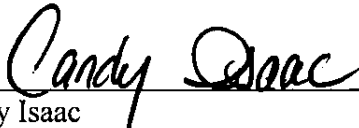

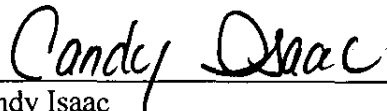
