## ARTICLES OF ORGANIZATION OF

Kathleen and William Hughes, LLC, a Florida Limited Liability Company



The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

## ARTICLE I

The name of the limited liability company (the "Company") is **Kathleen and William Hughes, LLC,** a Florida limited liability company.

## ARTICLE II PRINCIPAL PLACE OF BUSINESS

Unless otherwise set forth in the Operating Agreement and Regulations of the Company, any one Manager shall have full authority to act on behalf of the Company and each acting individually shall have all powers and authority granted to a "Manager" under the Florida Limited Liability Act. Until such time as a successor or substitute is elected, appointed or designated in accordance with the Operating Agreement and Regulations, the Manager of the Company shall be as follows:
