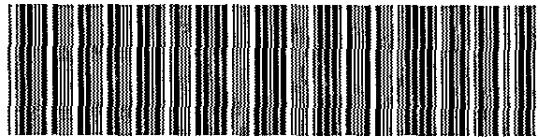

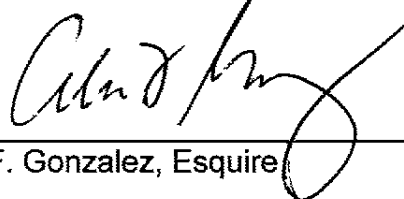

ARTICLE V – BUSINESS PURPOSE

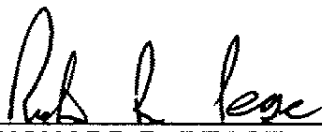
The primary business purpose of this Company shall be to offer tractor and equipment repair services, as well as any other purposes permitted by Florida law.
