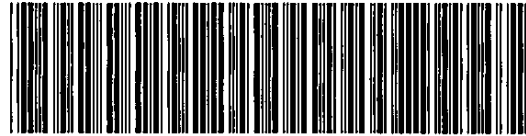



The period of duration for Chuck Hooker Lawn Maintenance, LLC shall be perpetual.


