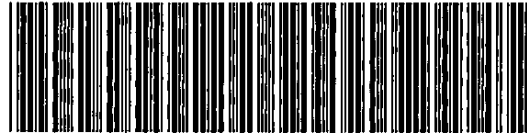

ARTICLE I

Name


