

ARTICLE IV

Transferability of Membership Interests

Unless otherwise provided in the Company's Operating Agreement, there shall not be any distribution of profits unless each separate distribution is approved by the affirmative vote of

members who own more than fifty per cent (50%) of the voting interest in the Company. The voting members shall have complete discretion on when and if to approve any distribution of profits.


