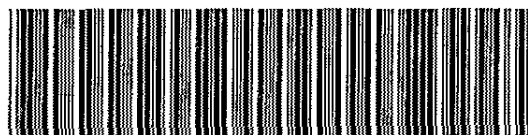

The period of duration for TeePee Properties, LLC shall be perpetual.


ARTICLE IV - Registered Agent:
