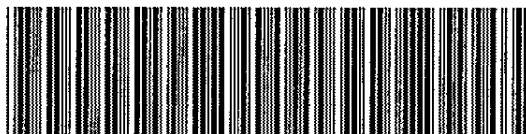

**ARTICLES OF ORGANIZATION
OF
MLA, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act (the Florida Act), hereby adopts and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be:

MLA, LLC

(hereinafter referred to as the "Company")

ARTICLE II - TERM

The term of the Company shall begin on the filing of the Articles of Organization with the Florida Secretary of State, and shall have perpetual existence, unless the Company is earlier dissolved by the Members or as provided by the Florida Act.




