**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be TOP-ONE CENTRAL FLORIDA, LLC ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 1643 Lookout Landing Circle, Winter Park, FL. 32789.

ARTICLE III

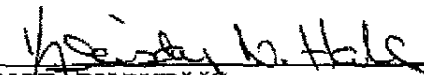
