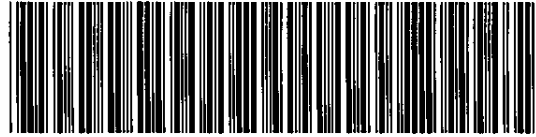

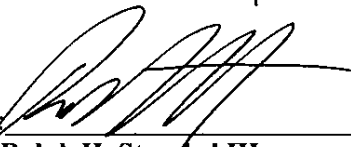

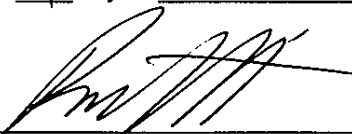
- FIRST: This Article amends the Articles of Organization of **DeanandFifty, LLC, a Florida Limited Liability Company.**
