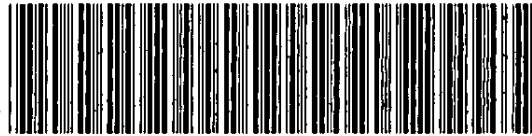

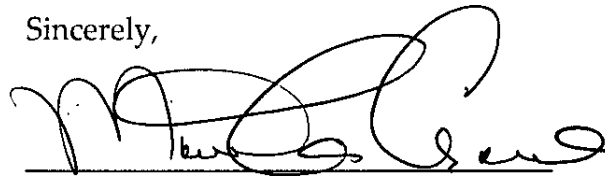

The registered agent for the company ("Company") is Matthew S. Grace, 2222 Merrill Avenue, Jacksonville, Florida 32207.

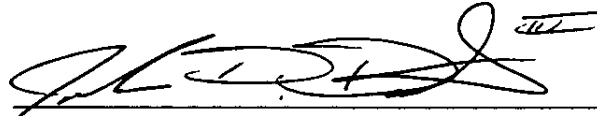
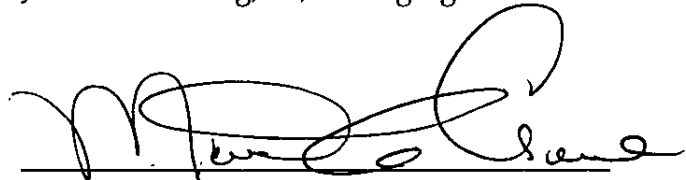
