ARTICLE I:

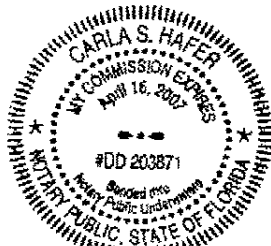

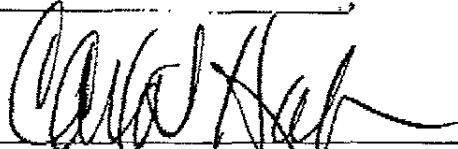
