

#### Articles of Organization

of

#### 369 Industrial Boulevard, LLC

#### A Florida Limited Liability Company



- I. Name. The name of this limited liability company is 369 Industrial Boulevard, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
- 2. <u>Duration</u>. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.
