Articles of Organization

of

Veterans Boulevard Commercial, LLC

A Florida Limited Liability Company

- 1. Name. The name of this limited liability company is Veterans Boulevard Commercial, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
- 2. <u>Effective Date</u>. The effective date of these Articles of Organization shall be October 4, 2006, and the Company's existence thereafter shall be perpetual.
- 3. <u>Purpose</u>. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida.

If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring member shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.
