**ARTICLES OF ORGANIZATION FOR  
FREE RIDE ENTERPRISES, LLC, a  
Florida Limited Liability Company**

**ARTICLE I - NAME**

The name of the Limited Liability Company is **FREE RIDE ENTERPRISES, LLC**

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the Limited Liability Company is 2801 SW College Rd., Suite 9, Ocala, Florida, 34474.

**ARTICLE III - DURATION**

The period of duration for the Limited Liability Company shall be perpetual, subject to earlier dissolution as otherwise provided by law.

**ARTICLE IV - Management**

This Limited Liability Company is to be managed by a Manager. The initial Manager of this LLC shall be appointed by the Subscribing Member. Thereafter, the Manager shall be changed only by vote of a majority of the Members entitled to vote. The Subscribing Member shall also have the sole authority to adopt an Operating Agreement for this LLC, which Operating Agreement may provide for classes of Members having such relative rights, powers and duties as therein provided, including a class of non-voting Members. The Operating Agreement of this LLC shall be subject to amendment only by majority vote of the Members entitled to vote, except in those instances where a vote of all Members is required by law.

**ARTICLE V - TRANSFERABILITY**

**5.1 Transferee Not Member in Absence of Consent.**

If a Majority of the Members entitled to vote (not including the transferring Member) do not approve of the Transferring Member's proposed transfer of his Membership Interest, whether by sale, gift or otherwise, to a transferee who is not a Member immediately prior to the transfer, then the proposed transferee shall have no right to participate in the management of the business

and affairs of the Company or to become a Member. Such transferee shall be merely an Economic Interest Owner.

**ARTICLE VI – Admission of Additional Members**

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:

From the date of formation of this LLC, any person or entity acceptable to a majority of the Members entitled to vote, may become a Member of this LLC, either by the issuance of additional membership interests of a class and for such consideration as specified by the vote, or as a transferee of a Member's membership interest of a specific class, or any portion thereof, subject to the terms and conditions of Article V of these Articles of Organization.
