# ARTICLES OF ORGANIZATION OF JULIA'S HOUSE, L.L.C.

The undersigned members to these Articles of Organization hereby associate themselves together to form a Limited Liability Company under the laws of the State of Florida.

#### ARTICLE I

#### NAME

The name of this Limited Liability Company is JULIA'S HOUSE, L.L.C.

#### ARTICLE III

#### **GENERAL NATURE OF BUSINESS**

The Limited Liability Company may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

#### ARTICLE III.

#### MEMBERSHIP

All memberships shall be payable in cash, notes, or other property at a valuation to be fixed by the Board of Managers at a meeting called for that purpose. Property may be purchased or paid for with memberships at a just valuation to be fixed by the Board of Managers. The members by vote of a majority interest may sell further memberships as they deem necessary at a price to be determined in their discretion. Any new memberships interests shall reduce the existing percentages pro-rate. However, whenever new membership interests are sold the existing members shall have preemptive rights.

#### **ARTICLE IV**

#### INTIAL AND AUTHORIZED CAPITAL

The amount of capital with which this Limited Liability Company will begin business is not less than \$100.00, to be contributed as set out in Article IX. The authorized capital shall be \$1,000.00 but may be increased by amending these articles as provided in article X.

#### ARTICLE V

#### TERM OF EXISTENCE

This Limited Liability Company is to exist in perpetuity. The Limited Liability Company will continue without regard to the death, retirement, resignation, expulsion, bankrupucy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Limited Liability Company.

#### ARTICLE VI

#### **ADDRESS**

The principal office and mailing address of this Limited Liability Company in the State of .

Florida is 3840 Kent Court, Miami, Florida 33133. The Board of Managers may from time to time move the principal office to another address in Florida.

#### ARTICLE VII.

#### **MANAGERS**

This Limited Liability Company shall, if voted by members, have not less than one manager, however, the number of managers may be increased or diminished from time to time by Regulations adopted by the stockholders, but shall never be less than one. The Managers may manage the Limited Liability Company in accordance with regulations passed by the members of the Limited Liability Company as the members may desire.
