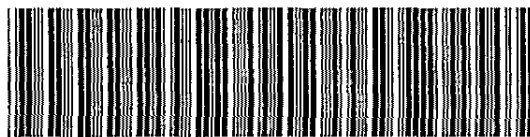



The mailing address and street address of the principal office of the Limited Liability Company is 100 N. Federal Highway, Unit 1518, Fort Lauderdale, FL 33301.


**ARTICLE III – Purpose**
