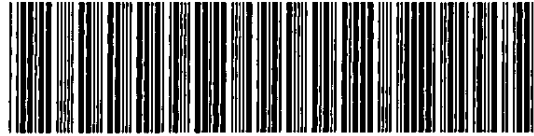



NAME




