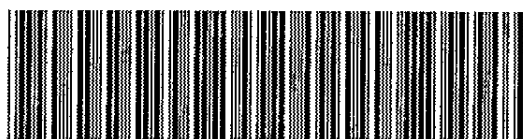




**ARTICLE II – Address**

**ARTICLE IV – Duration**


The existence of the Company shall be perpetual.
