**ARTICLE VIII ADMISSION OF NEW MEMBERS**

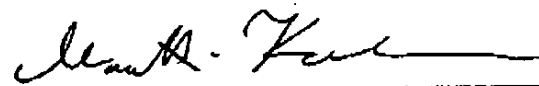
